

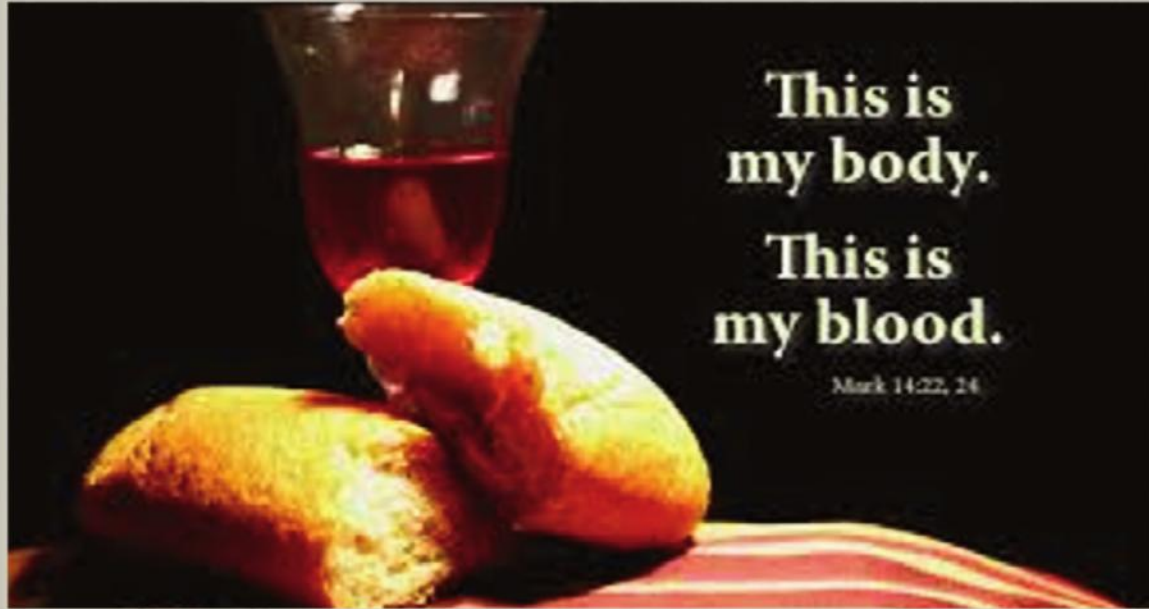

Deacon Ben's Corner

Being a Deacon

On May 1, I answered several questions from Bishop Persico in order to declare before the people my intention to undertake the office (of being a deacon). The questions centered upon being consecrated to the Church's ministry, to minister with humble charity, to hold fast to the mystery of faith, to remain celibate for the sake of the Kingdom, to deepen a spirit of prayer, to conform my way of life to the example of Christ, and obedience to the bishop and his successors. I answered "I do" to all of the questions, but one question required "I do, with the help of God."

The question is, "Do you resolve to conform your way of life always to the example of Christ?" I believe it's this question which is the grounds upon which all the other aspects of ministry, being a deacon, studying for the priesthood, growing in holiness, etc. is built upon. Another reason why I love this question is because it's something you and I can answer together. I will look to many of you to see how this question is lived out.
